Supplementary regulations

Article 1 : Organizer

By delegation of the FIM (Fédération Internationale de Motocyclisme), the tourism committee of the MUL (Motor-Union Luxembourg, the national federation of motorcycling) is organising an international gathering (reserved for category A) called the

2010 FIM Rendez-Vous Meritum

which will take place in Ettelbruck, Grand Duchy of Luxembourg, from the 18th to the 20th of June 2010.

This event of the FIM calendar will be organised in accordance with the FIM Code for Touristic Gatherings, Meritum and with the General Rules of the FIM Commission for Leisure Motorcycling (CML) and the present supplementary regulations. The address of the organizer and the secretariat is:

Article 2 : Participation

In accordance with the FIM Code, to be admitted the qualified participants must:

- Be affiliated with a National Motorcyclist Federation (NMF)
- Be a holder of a FIM Insignia of Honour, either the “Meritum ” or “Co-Meritum”

Accompanying passengers who don't hold the “Meritum FIM” or “Co-Meritum FIM” are also admitted.

2010 FIM Rendez-Vous Meritum / Supplementary regulations

Article 3: Registration

Individual registration in advance is mandatory. This can be done by filling in the **registration form**, in duplicate according to the FIM rules, and accompanied with the required documentation proving membership of either "Meritum FIM" or "Co-Meritum FIM", as stated under article 2.

These forms must be sent:

- to the address of the organizer by mail
- or by fax to (+352) 26 008 443
- or to the email address meritum@mul.lu (scanned document)

A copy must be sent to the national federation of the participant. The national federations may also gather the registration forms of their members and send them all together to the MUL at the address above, by the deadline mentioned in Article 5.

Article 4 : Enrolment fee

The enrolment fee for each participant who holds a 'Meritum FIM' or a 'Co-Meritum FIM' is 110 euros. The same amount is due by the accompanying person who does not hold a 'Meritum FIM' or 'Co-Meritum FIM'.

A reduction of 50% is granted to children aged between 8 and 16. Children below the age of 8 years are admitted free of charge.

This registration fee does not include the cost of housing, camping, or breakfast (camping). The registration fee will not be returned in case of non participation.

The enrolment fee and the cost of accommodation must be transferred before the 1st of May 2010 exclusively on the account below:

Article 5: Closing of registrations

The deadline for registration is midnight on the 1st of May 2010. By this time, every registration form, accompanied with the full enrolment fee, has to be sent to the organizer by post (without expense for the organizer), fax or e-mail.

Article 6: Benefits and advantages for participants

Following his/her registration, each participant will receive:

- A souvenir gift, medal or plaque of the 2010 FIM Rendez-Vous Meritum;
- Participation in excursions with a tour guide;
- A guided tour in Ettelbruck and Luxembourg;
- A dinner and a closing banquet.

Article 7: Accommodations

The camping and the hotel must be booked with the registration form. If the capacity of the hotel 'By Dahm' at Erpeldange is exceeded, the organizer reserves the right to propose an accommodation of a similar quality near the city of Ettelbruck.

There will be no "parc fermé". However supervised parking areas may be installed at various places in Ettelbruck and in Luxembourg-city.

Article 9 : Results and ranking

As the 2010 FIM Rendez-Vous Meritum is an international meeting with the intension to reinforce friendship, no ranking will be established. Nevertheless the organizers reserve the right to reward certain participants at their discretion.

Article 10 : Cancellation

The organizer has the right to cancel the event if the number of individual pre-registrations is less than 100 on the 1st of May 2010 (when registrations close) or in case of absolute necessity. If this happens, the registered participants will immediately be informed and the fee will be returned.

Article 11 : Responsibility

The event consists of a simple friendly gathering and the participants will be personally responsible for any violation of the rules, laws and dispositions in the various transit countries. Every participant's vehicle has to be registered and insured for all of these countries. The organizer has no responsibility for any damage to the participants or to their goods (before, during, and after the gathering).
